THE CII IS FUNDED PRIMARILY THROUGH GRANTS AND INDIVIDUAL CONTRIBUTIONS. THE PROGRAM STARTED AS A PARTNERSHIP WITH PRINCETON NURSERY SCHOOL AND HAS EXPANDED TO SERVE PRINCETON PUBLIC, WEST WINDSOR-PLAINSBORO, AND CRANBURY SCHOOL DISTRICTS.
